Privacy Policy

Basic Income Australia Limited ('the Company', 'we', 'us', our') is committed to achieving implementation of a Universal Basic Income in Australia and this policy outlines our ongoing obligations to you in respect of how we manage your Personal Information, as and when you engage with us in this vital endeavour.

What is Personal Information and why do we collect it?

Personal Information is information or an opinion that identifies an individual. Examples of Personal Information we collect includes names, addresses, email addresses, phone and facsimile numbers, as well as usernames provided by you when logging onto our services.

This Personal Information is obtained in many ways that may include interviews, correspondence, by telephone and facsimile, by email, via our website www.basicincomeaustralia.com, and via third-party services that we use to communicate with you, such as Facebook, Instagram, Discord, Trello, Miro, Meetup, and YouTube, or other third-party services we may use from time to time to communicate with members, supporters, donors, and volunteers of the Company, and the public; as well as from your website, from media and publications, from other publicly available sources; from cookies, and from third parties. We don't guarantee website links or policy of authorised third parties.

We collect your Personal Information for the primary purpose of communicating with you regarding the purposes of the Company as set out in our Constitution and Policy, as well as for soliciting donations, and to offer you merchandise or paid activities related to the purposes of the Company. We may also use your Personal Information for secondary purposes closely related to the primary purpose, in circumstances where you would reasonably expect such use or disclosure. You may unsubscribe from our mailing/marketing lists at any time.

When we collect Personal Information we will, where appropriate and where possible, explain to you why we are collecting the information and how we plan to use it.

Sensitive Information

Sensitive information is defined in the Privacy Act to include information or opinion about such things as an individual's racial or ethnic origin, political opinions, membership of a political association, religious or philosophical beliefs, membership of a trade union or other professional body, criminal record or health information.

Sensitive information will be used by us only:

- For the primary purpose for which it was obtained
- For a secondary purpose that is directly related to the primary purpose
- With your consent; or where required or authorised by law.

Disclosure of Personal Information

Your Personal Information may be disclosed in a number of circumstances including the following:

- If you are a member of the Company, any details held in our Register of Members to other members upon request.
- Third parties where you consent to the use or disclosure; and
- Where required or authorised by law.

Security of Personal Information

Your Personal Information is stored in a manner that reasonably protects it from misuse and loss and from unauthorized access, modification or disclosure.

However, most of the Personal Information is or will be stored in member, supporter, donor and volunteer databases which will be kept by us for a minimum of 7 years.

Access to your Personal Information

You may access the Personal Information we hold about you and to update and/or correct it, subject to certain exceptions. If you wish to access your Personal Information, please contact us in writing.

Basic Income Australia Limited will not charge any fee for your access request but may charge an administrative fee for providing a copy of your Personal Information.

To protect your Personal Information, we may require identification from you before releasing the requested information.

Maintaining the Quality of your Personal Information

It is an important to us that your Personal Information is up to date.

If you find that the information we have is not up to date or is inaccurate, please advise us as soon as practicable so we can update our records and ensure we can continue to provide quality services to you.
